Abstract

The Iowa Association of Electric Cooperatives (IAEC) is the Des Moines-based service organization representing the state's rural electric cooperatives, originally established in 1942 under the name Iowa Rural Electric Cooperative Association (IRECA). The collection contains correspondence and memorandums, meeting minutes, programs, speeches, presentations, press releases, newsletters, news clippings, reports, financial statements, franchise applications, advertising material, surveys, directories, legal orders and statements, photographs, printed materials, and 1 magnetic audio reel. The records document the activities of the IAEC departments, committees, concerns and activities, individual cooperatives, and associated professional and civic organizations. Also included are records from the National Rural Utilities Cooperative Finance Corporation (CFC).

Historical note

The Iowa Association of Electric Cooperatives (IAEC) is the Des Moines-based service organization representing the state's rural electric cooperatives, originally established in 1942 under the name Iowa Rural Electric Cooperative Association (IRECA). In the 1930s, when large electric companies neglected the sparsely-populated rural areas, communities in these areas used federal loan money administered through the Rural Electrification Administration (REA), established in 1935, to develop their own electric cooperatives. The IAEC represents 34 distribution cooperatives in Iowa and seven generation and transmission cooperatives providing electricity to approximately 650,000 Iowans in each of the state's 99 counties. The organization's mission is to deliver "power that is safe, reliable, environmentally responsible, and affordable." The IAEC supports its member cooperatives by providing legislative representation at the state and national levels; safety programs, demonstrations and campaigns; electrical promotion programs that encourage safe use of electricity and efficient appliances and equipment; education and training programs; communication resources and services; youth activities; a statewide disaster plan to help restore power quickly and safely during emergencies; and review and monitoring of utility regulations.

The IAEC is part of a national network of electric cooperatives, the National Rural Electric Cooperative Association (NRECA), a Washington, D.C.-based service organization formed in 1942. In August 1967, NRECA appointed the Long-Range Study Committee to determine how to meet electric cooperatives' future financing needs. The result of the study committee was the incorporation in 1969 of the National Rural Utilities Cooperative Finance Corporation (CFC), a member-owned, nonprofit cooperative established to raise funds from capital markets to supplement the loans from REA (now Rural Utilities Service). Earl L. King, Manager and Executive Vice President of IAEC from the 1950s through the 1970s, also served as Chairman of CFC District 5 (Wisconsin, Iowa, and Illinois).

Collection description

The collection (1937-1978, undated) contains correspondence and memorandums, meeting minutes, programs, speeches, presentations, press releases, newsletters, news clippings, reports, financial statements, franchise applications, advertising material, surveys, directories, legal orders and statements, photographs, printed materials, and 1 magnetic audio reel. The records document the activities of IAEC departments (Board of Directors, Accountants Section, Managers Section, Member Services Section, Sales and Services Section, Job Training and Safety, and Iowa Rural Electric Cooperative News), committees (advertising, budget, Public Information Advertising (PIA), Public Utilities Regulation, Rural Area Development, and Resolutions), concerns and activities (legislative matters, taxation and tax equity, and youth tour), individual cooperatives, and associated professional and civic organizations. Also included are records from the National Rural Utilities Cooperative Finance Corporation (CFC).

File groupings include IAEC departments, committees, concerns and activities, individual cooperatives, and associated professional and civic organizations. Also included are files related to the Electric Power Research Institute (EPRI) and its rate design study, which administrators of IAEC participated in as part of Task Force 8. The series is arranged alphabetically by file grouping and chronologically within each grouping.
